OPERATING INSTRUCTIONS

1. Ensure power cord is disconnected.
2. Open bulb cage and install new bulb (75W max rating), then close bulb cage.
3. Fully extend power cord, then install into any 110 - 125V, grounded electrical outlet.

Note: This product has a 3-prong grounded electrical plug. The plug must be used with an outlet that is properly installed and grounded in accordance with local codes and ordinances. If using an extension cord, make sure it is the proper configuration for a grounded connection.

4. Depress ON/OFF switch in handle to turn light on.

BULB REPLACEMENT INSTRUCTIONS

1. Ensure power cord is disconnected.
2. Open bulb cage and install new bulb (75W max rating).
3. Close bulb cage.
